**SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007**

**Order under Section 2 and Section 5**

1. BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act No. 48 of 2007, I, Basil Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column (i) of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entries in Column (ii) of that Schedule.

2. By virtue of the powers vested in me by Section 5 of the Special Commodity Levy Act, No. 48 of 2007, I do hereby make an order to waive-off balance amount after collecting Rs. 1 per kg from the applicable Special Commodity Levy of Rs. 10 per Kg in importation of Maize, listed out in the Schedule of the above, for production of "Thripsha" by Sri Lanka Thripsha Limited.
3. This Order shall be valid for a period of 6 months commencing from March 04, 2022 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
