SPECIAL COMMODITY LEVY ACT, NO. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Basil Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto the Special Commodity Levy at rates specified in the corresponding entries in Column II of that Schedule.

This order shall be valid for a period of 06 months commencing from March 10, 2022, subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The order made under Sections 2 and 5 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette* Notification No. 2240/20 of August 11, 2021 in respect of Butter and other related products (HS Codes 0405.10, 0405.20, 0405.90), the Orders made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in



the *Extraordinary Gazette* Notification No. 2236/66 of July 18, 2021 in respect of Cheese (HS Code 0406.20), *Extraordinary Gazette* Notification No. 2228/3 of May 17, 2021 in respect of Yogurt (HS Codes 0403.10 and 0403.20), Dates (HS Codes 0804.10.10, 0804.10.20), Fresh Oranges (HS Code 0805.10.10), Grapes (HS Codes 0806.10, 0806.20) Apples (Hs Code 0808.10) and the Order published in the *Extraordinary Gazette* Notification No. 2225/1 of April 26, 2021 in respect of Other Fruits (HS Codes 0810.90.90) are rescinded with effect from March 10, 2022.
