Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government has acquired the allotment of land for the development of the Canal from No. 15/25, 2nd Lane, Pepiliyana Mawatha, Kohuwala to Depa Ela located adjacent to the house at No. 327/2, Ranasinghe Mawatha Pepiliyana Boralesgamuwa and for the construction of the maintenance path of the canal under Weras Ganga Storm Water Drainage and Environment Improvement Project.
