ORDER UNDER PROVISO (a) TO SECTION 38

- 2. **Description of the land.** An allotment of land morefully described in below name and extent in the Advance Tracing No. CO/KSB/2021/547, prepared by the Senior Superintendent of Survey Colombo District, situated in the Village called Bellanthara (within the limits of Boralesgamuwa Urban Council) in the Grama Niladhari Division No. 535A of Bellanvila in the Divisional Secretary's Division of Kesbewa in Colombo District of Western Province and bounded as follows:
