**UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 25A**

BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Dinesh Gunawardena, the Minister of Education having obtained a report under Section 70C of the aforesaid Act, in respect of the SLT Campus (Private) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number PV 101137, do by this Order amend the Schedule II to the Order made under said Act, and published in *Gazette Extraordinary*, No. 2210/18 of January 13, 2021 by the addition immediately after entry “Bachelor of Music Honours” appearing in Column I and its corresponding entry in Column II thereof, of the entries specified under Column I and II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto.

**SCHEDULE I**

**CONDITIONS**

1. SLT Campus (Private) Limited shall, when admitting students for the degree programme specified in Schedule II hereto in respect of the Bachelor of Science in Textile and Clothing Technology, adhere to the minimum entry qualification of three (03) simple passes (S) in approved subjects in Physical Science or Biological Science Stream or Technology Stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examination of Sri Lanka or equivalent.
