I hereby give notice, under Sub-Section (1) of Section 7, of Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/ servitude which is required for Quarters of the Divisional Secretary, Yatawatte and that of the Assistant Divisional Secretary.

Description of the Land to be Acquired:

An allotment in extent of 0.3062 hectare of the land called Dangan Watte depicted in the Preliminary Plan No. MA 1855 prepared by the Surveyor General, situated in the village called Deevilla in the Grama Niladhari Division No. E 337B of Dangan Place in Asgiri Pallesiya Pattu Minor Division in the Divisional Secretary's Division of Yatawatte in Matale District of the Central Province.
