FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE PALAGALA PRADESHIYA SABHA UNDER SECTION 66A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
