**ORDERS**

Provincial Environmental (Protection and Quality) Order No. 01 of 2010 published in Extra Ordinary *Gazette* No. 1685/11 of 21st of December, 2010 is hereby amended as follows;



1. By substitution of the following paragraph for paragraph (b) of order No. 6,

“(b) A license should be valid for such period as shall be specified in the license, that shall not be more than a period of three years, subject to suspension or cancel under Section 21(2) of the statute.”

2. By substitution of the following items for general terms and conditions in format (b) in schedule II.

“1. A license should be valid for such period as shall be specified in the license; such period shall not exceed 3 years since the date of issue of the license. An application for renewal shall be made one month prior to the expiration of the license.”

## ORDERS

Project Approving Orders published in the Extraordinary Gazette No. 1020/21 of 27th March, 1998 are amended as follows:

1. By repeal of paragraph (iii) of the 4th order in it,
2. By repeal of paragraph (i), paragraph (ii) and paragraph (iii) of the 9th order in it,
3. By substitution of the following orders for the 10th Order in it;

“On receipt of initial environmental examination report, within a 21 days period of time, the project approval agencies shall,

- (i) grant the approval to implement the proposed project, subject to the specified conditions; or
- (ii) a request shall be made from the project proponent to submit an Environmental Impact Assessment Report;  
or
- (iii) the approval for implementation of the proposed project shall be refused stating the reasons for rejection”.
