#### FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE DOMPE PRADESHIYA SABHA UNDER SECTION 66A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of return member of Dompe Pradeshiya Sabha has fallen vacant by reason of not attending three consecutive meetings without obtaining permission;
