I hereby give notice, to the public under Sub - section (1) of the Section 7 of the Land Acquisition Act, as amended by Land Acquisition Act (Amendment) No. 28 of 1964 that the land described below is required by the government and the government intends to acquire the said land/servitude for public purpose.
