FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE SRI JAYAWARDANAPURA KOTTE MUNICIPAL COUNCIL UNDER SECTION 66A (1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
