By virtue of powers vested in me by Section 4 of the Forest Conservation Ordinance (Chapter 451) as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995, and No. 65 of 2009, I, Wimalaweera Dissanayake, Minister of Wildlife & Forest Resources Conservation do by the release 27.3684 ha. of Rajawaka Reserved Forest located within below-mentioned Schedule 1(0.5716ha.), Schedule 2 (19.3426ha), Schedule 3(4.1712 ha.), Schedule 4 (2.8381 ha.) and schedule 5(0.4449ha.) was declared as a Reserved Forest by the *Gazette Extraordinary* Notification No.1577/5 dated 25th November 2008, from the reserved forest state from 27th day of April, 2022.

SCHEDULE 1
