WAGES BOARD FOR THE BATIK TRADE

IN pursuance of the authority conferred on me by the Minister of Labour by an order made by him under Section 33(1) (a) of the Wages Boards Ordinance (Chapter 136) and published in *Extraordinary Gazette* No. 48 of 03rd August 1979, I. B. K.
