WAGES BOARD FOR THE BATIK TRADE

IN pursuance of the authority conferred on me by the Minister of Labour by an order made by him under Section 33(1) (a) of the Wages Boards Ordinance (Chapter 136) and published in *Extraordinary Gazette* No. 48 of 03rd August 1979, I. B. K. Prabath Chandrakeerthi, Commissioner General of Labour hereby notify under Section 28 of the aforesaid Ordinance, and I propose to determine under Section 33(2) of that Ordinance the minimum rate of wages for time work set out in the Schedule hereto in respect of the workers in the Batik Trade.
