#### RESOLUTION

This Parliament resolves, under Section 10 of the Customs Ordinance (Chapter 235) that, with effect from the date on which this resolution is notified in the *Gazette* import duties under the Customs Ordinance (Chapter 235), shall be levied and paid on the articles specified in Column 3 of the Schedule hereto at the general rates set out in the corresonding entries in Column 5 of that Schedule, or where preferential rates are leviable and payable under the provisions of Scheudle "A" to the Customs Ordinance (Chapter 235) at the preferential rates set out in the corresponding entries in Column 4 of that Schedule and insert the new item No. 40 of List of Exemptions (Imports), Annex II under the Schedule "A" of the Customs Ordinance (Chapter 235) of the *Extraordinary Gazette* Notification No. 2220/42 dated March 24, 2021 as describe in the Annex I.
