I hereby give notice, under section 7 Sub-section (1) of the Land Acquisition Act, No. 28 of 1964, as amended by the Land Acquisition Amendment Act that the Government intends to acquire the following lands, which is required for construction of the intake pump house under Gampaha, Attanagalla, Minuwangoda intergrated Water Supply Scheme.
