### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Samarakoon Mudiyanselage Chandrasena, Minister of Lands do hereby declare, under Sub-section (1) of Section 5 of the land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.
