PARLIAMENTARY ELECTIONS ACT No. 1 OF 1981

Filling of a Vacancy under Section 64 (5)

WHEREAS the Secretary General of the Parliament has informed the Election Commission under Section 64(5) of the Parliamentary Elections Act, No. 1 of 1981, as amended by Section 6 of the Elections (Special Provisions) Act, No. 35 of 1988, that a vacancy has occurred in the membership of Parliament by reason of the resignation of **Mr. Basil Rohana Rajapaksa** being a member nominated by the Sri Lanka Podujana Peramuna, a recognized political party, and declared elected as a Member of Parliament under Article 99A of the Constitution ;

And whereas the Secretary of that Political Party was required by the Election Commission under the aforesaid a Section to nominate a member of such party to fill such vacancy ;

And whereas the Secretary of the aforesaid Political Party has nominated **Mr. Kulappu Arachchige Don Dhammika Perera** to fill such vacancy;

Now therefore, the Election Commission, in the exercise of the powers conferred by Section 64 (5) of the Parliamentary Elections Act, No. 1 of 1981 to be read together with the provisions of the Constitution of the Democratic Socialist Republic
