WAGES BOARD FOR THE FLOWERS, ORNAMENTAL PLANTS, VEGETABLES AND FRUIT GROWING AND EXPORT TRADE

IN Pursuance of the powers conferred on me by an order made by the Minister of Labour under section 33(1) (a) of the Wages Boards Ordinance (Chapter 136) published in the *Gazette Extraordinary* No. 1916/12 of May 27, 2015, I, B. K. Prabhath Chandrakeerthi, Commissioner General of Labour, do hereby notify under section 28 of the aforesaid ordinance that I intend to determine minimum daily wages in respect of the workers engaged in Flowers, Ornamental Plants, Vegetables and Fruit Growing and Export Trade set out in the below schedule, under section 33 (2) of that ordinance.

Objections to the proposed determination will be received by me until 12.00 noon on 15th July 2022.

SCHEDULE

The decisions made by the Wages Board for the Flowers, Ornamental Plants, Vegetables and Fruit Growing and Export Trade set out in the schedule to the notification published in *Extraordinary Gazette* No. 1748/16 of 09th March 2012 and last varied by the Notification published in *Extraordinary Gazette* No. 2028/6, of 17th July 2017, shall be revised varied as follows.

The minimum rate of wages applicable to the workers in the Flowers, Ornamental Plants, Vegetables and Fruit Growing and Export Trade specified in part I, shall be the rates set out in the corresponding entry in part II.

Part I

Class of Workers

Skilled : Tissue and seed cultivators, workers engaged in grafting, workers engaged in arranging Flower plants, Flowers and branches for export and sale, workers engaged in arranging ornamental plants and parts of plants, quality controllers, workers engaged in spraying fungicides, insecticides and manuring, packers, store keepers, men-in-charge of workers administration, workers engaged in activities which need a training.

Semi-Skilled : Workers engaged in preparation of nursery beds, planting seedlings and maintenance, product pluckers and collectors, store assistants, other semi-skilled workers.

Un-Skilled : Workers engaged in preparation of land, loading and unloading labourers, workers engaged in order activities which do not need a training.
