FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE POTTUVIL PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of member of Pottuvil Pradeshiya Sabha has fallen vacant by reason of Resignation;

And whereas the Secretary of the United National Party, the recognized political party to which Muhammadu Sarifu Abdul Wahid the member belonged, was required by me under Section 66A(1)(a) of the aforesaid Ordinance, to decide upon the member of that Number 3 Hidayapuram of Pottuvil Pradeshiya Sabha who belongs to such party and is not disqualified under Section 9 of the Local Authorities Elections Ordinance (Chapter 262) and who shall be declared elected as a member within a period of thirty (30) days;

FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE ADDALACHCHENEI PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of member of Addalachchenei Pradeshiya Sabha has fallen vacant by reason of death;
