#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Samarakoon Mudiyanselage Chandrasena, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotment of land described below, depicted in Surveyor General's Advance Tracing No.MA/NUL/2015/287 dated 05.08.2016, situated at No. (F.V.P.257), Karawilahena village in Wagapanaha Udasiya Pattuwa minor Division of Naula Divisional Secretary's Division, Matale District, Central Province and bounded as follows.
