1. **Acquiring Officer.**— Divisional Secretary, Kandy Four Gravets and Gangawata Korale.

2. **Description of the Land.**— The allotments of land depicted in below names and extents in the Advance Tracing No. Maha/MHN/2019/272 dated 30.09.2021 prepared by the Surveyor General, situated in the Villages called Welata, Bowala (in the limits of Kandy Municipal Council) in the Grama Niladhari Division No. 220 of Getambe, 244 of Udobowala in the Divisional Secretary's Division of Kandy Kadawath Sathara and Gangawata Korale in Kandy District of Central Province and bounded as follows:

01. **Lot 'A' – Udagangul Kumbura – Extent: 0.5130 Hectare**

04. Lot 'D' - Wahalawela Kumbura - Extent: 0.0242 Hectare

06. Lot 'F' - Udagangul Kumbura - Extent: 0.0523 Hectare

North: Meda Ela (Stream), Wahalawela claimed by Urban Development Authority and some others and Lot G; East: Meda Ela (Stream) and Lots A, E; South: Lots A, E and Meda Ela (Stream); West: Meda Ela (Stream) and Wahalawela claimed by Urban Development Authority and some others.

07. Lot 'G' - Udagangul Kumbura - Extent: 0.0016 Hectare

North: Wahalawela claimed by Urban Development Authority and some others; East: Wahalawela claimed by Urban Development Authority and some others; South: Meda Ela (Stream) and Lot F of this tracing; West: Wahalawela claimed by Urban Development Authority and some others.

08. Lot 'H' - Wahalawela - Extent: 0.1170 Hectare

North and East: Wahalawela claimed by Urban Development Authority and some others; South: Meda Ela (Stream); West: Lot J.

09. Lot 'J' - Wahalawela, Siriyage Kanatiya *alias* Thanakola Kotuwa - Extent: 0.2551 Hectare

North: Lot L and Wahalawela claimed by Urban Development Authority and some others; East: Lot H; South: Meda Ela (Stream); West: Lots K and L.

10. Lot 'K' - Wahalawela - Extent: 0.0270 Hectare

North: Lot L; East: Lot J; South: Lot J and Meda Ela (Stream); West: Meda Ela (Stream) Lot L.

11. Lot 'L' - Wahalawela - Extent: 0.1240 Hectare

North: Railway and William Gopallawa Mawatha; East: Wahalawela claimed by Urban Development Authority and some others; South: Lots J and K; West: Lot K, Meda Ela (Stream) and Railway.
