FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE THUNUKKAI PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of member of Thunukkai Pradeshiya Sabha has fallen vacant by reason of not attending council meetings for a period of three months without permission ;

And whereas the Secretary of the Ilankai Tamil Arasu Kadchi, the recognized political party to which Kanapathippillai Niruban the member belonged, was required by me under Section 66A(1)(a) of the aforesaid Ordinance, to decide upon member of that Ward No. 08 Bharathinagar of Thunukkai Pradeshiya Sabha who belongs to such party and is not disqualified under Section 9 of the Local Authorities Elections Ordinance (Chapter 262) and who shall be declared elected as a member within a period of thirty (30) days ;

And whereas the Secretary of the aforesaid recognized political party has communicated his decision to nominate Subramaniam Raththinasigam to fill such vacancy;
