FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE CHAVAKACHCHERI PRADESHIYA SABHA UNDER SECTION 66A (1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of member of Chavakachcheri Pradeshiya Sabha has fallen vacant by reason of resignation;
