I hereby give notice, under Sub section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land of Undugoda-Yatideriya Estate which is required for resettling the people displaced due to the Landslide occurred in 2016 in Divisional Secretary's Division of Kegalle:
