#### FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KANTHALE PRADESHIYA SABHA UNDER SECTION 66A(1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS, the office of return Member of Kanthale Pradeshiya Sabha has fallen vacant by reason of not attending council meetings for a period of three months without permission.

And whereas the Secretary of the United National Party, the recognized political party to which Mohommadu Faruk Rahumani the member belonged, was required by me under Section 66A(1) of the aforesaid Ordinance, to decide upon returned member of Kanthale Pradeshiya Sabha who belongs to such party and is not disqualified under Section 9 of the Local Authorities Elections Ordinance (Chapter 262) and who shall be declared selected as a member within a period of thirty (30) days;
