UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 25A

BY virtue of powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education having obtained a report under section 70C of the aforesaid Act, in respect of the SLT Campus (Private) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number PV 101137, do by this Order amend the Schedule II to the Order made under said act, and published in *Gazette Extraordinary*, No. 2272/06 of March 21, 2022 by the addition immediately after entry “Bachelor of Science in Textile and Clothing Technology” appearing in Column I and its corresponding entry in Column II thereof, of the entries specified under Column I and II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto.

SCHEDULE I

CONDITIONS

1. SLT Campus (Private) Limited shall, when admitting students for the degree programmes specified in Schedule II hereto in respect of the Bachelor of Science in Fashion Merchandise Management and Bachelor of Applied Information Technology adhere to the minimum entry qualification of -
 - (a) three (03) simple passes (s) in any subject stream in one and the same sitting at the GCE (Advanced Level) Examination or an equivalent qualification;
