THE LAND ACQUISITION ACT, AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT, No. 28 of 1964 (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose :-

Description of the land/servitude to be acquired:

The allotments of land in total of extent of 1.2140 hectare, as Lot Nos. 1, 2, 3 and 4 depicted in the preliminary plan No. Ka 4871 and dated 28 July 2022, prepared by the Surveyor-General situated in the village of Iddagoda, in the Divisional Secretary's Matugama in the District of Kalutara in Western Province morefully described as follows :
