PRADESHIYA SABHA ACT, No. 15 OF 1987

Order

BY virtue of the powers vested in me by paragraphs (a), (b) and (c) of Section 9A of Pradeshiya Sabha Act, No. 15 of 1987, I, Dinesh Gunawardena, Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government, do hereby dissolve, Trincomalee Town and Gravets Pradeshiya Sabha constituted by the order published in *Gazette Extraordinary*, No. 453/20 of 12th May 1987, with effect from 19th March 2023 in order to constitute new Trincomalee Town and Gravets Pradeshiya Sabha replacing and having amended the limits and number of members.

PRADESHIYA SABHA ACT, No. 15 OF 1987

ORDER

By virtue of the powers vested in me under Sub-section (1) of Section 2, Section 4 and Section 6 of the Pradeshiya Sabha Act, No. 15 of 1987, I, Dinesh Gunewardena, Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government, do by this Order -



- (1) Declare the area specified in Part I of the Schedule hereto, to be a Pradeshiya Sabha area for the purposes of that Act;
- (2) Define the limits specified in Pradeshiya Sabha area to be the limits set out in Part II of that Schedule;
- (3) Constitute a Pradeshiya Sabha for the Pradeshiya Sabha area declared under paragraph (1) of this Order and assign the following name and designation to such Council:

“Trincomalee Town and Gravets Pradeshiya Sabha”

- (4) Prescribe that the Trincomalee Town and Gravets Pradeshiya Sabha shall consist of
 - i. Eleven members to be elected under paragraph (a) of Sub section (1) of Section 4 of Pradeshiya Sabha Act ;
 - ii. Seven members to be elected under paragraph (b) of Sub section (1) of Section 4 of Pradeshiya Sabha Act ;
 - iii. Such number of members determined by the Commissioner of Elections under paragraph (a) of Sub section (4) of Section 65B of the Local Authorities Elections Ordinance.
- (5) The term of office of the members of Trincomalee Town and Gravets Pradeshiya Sabha shall commence with effect from 20th March 2023.

SCHEDULE

PART I

The area of land comprising of the following Grama Niladari Divisions :

Sampalthivu (242), Salli (242-A), Eluppaikulam (242-B), Uppuveli (243), Puliyankulam (243-L), Andankulama (243-A), Mankaiyoottu (243-K), Peeliyady (243-J), Kanniya (243-B), Wilgama (243-E), Welveri (243-Q), Varothayanagar (243-N), Sumedhankarapura (229-B), Muththunagar (229-F), Kappalthurai (229-E), Kavaddikuda (229-D), Nachchikuda (229-C), Wellaimanal (229), Selvanayahapura (229-M), Mihindupura (229-1) Anpuvalipuram (243-C), China Bay (229-A).

PART II

Administrative limits of the Trincomalee Town and Gravets Pradeshiya Sabha :

North : From the point of 104th kilometer post in Anuradhapura - Trincomalee road. North - East wards, North ward and again North - East wards along the cart track to Kattkatkulam paddy field up to stream, its meet to Kandalkaadu - Pariyakulam Road (It's about 1 kilometers from Pariyakulam Tank). Then South - West ward, South ward along an arbitrary line across the full supply level contour of Pariyakulam tank and Pokkankulam tank and it meets inner Circular Road (about 2.12 kilometers from Trincomalee - Pulmoddai Road.) North - East wards, North - West wards again North - East wards through the center line of inner Circular Road up to Trincomalee - Pulmoddai Road it meets 6th kilometers post junction (called 6th mile post) Then North - East ward and East ward along the center line of Konesapuri Road (Eastern University road) up to sea coast of Indian Ocean.

- East* : From the last mentioned point South Ward and South East Ward along the sea coast till reach the center valarmathi lane running through 3rd kilometer post (called 3rd mile post) on Trincomalee - Pulmuddai Road. Then South ward, South - West wards in an arbitrary line meets to pillayar Kovil Road at Anpuvalipuram (about 0.3 kilometers from Trincomalee - Kandy Road, near the 158 Kilometer road post.) An West Ward South - West Wards, South - East Wards along the center line of Trincomalee - Kandy Road (156 kilometer post junction - called 4th mile post), through Trincomalee - Batticaloa Road to meet crossing the railway track (located near the entrance of cement factory) Then North - East wards and North East wards along the railway line (0.72 kilometer from railway cross till it meet sea coast at Mud Cove. Then South Ward, West Ward, South West Wards, East Wards, North East Wards, West Ward, South-West Wards along the Sea Coast (Mud Cove North cove, Mangrove Cove, Cod bay, China bay, Malay Cove, Snug cove, Clappenburg cove, Deadman cove (karimalai oottu), Periyamalaikudah Marble beach) up to Marble beach.
- South* : From the last mentioned point west ward, North west wards, South Wards, South West ward, South West wards again South West again sea coast across the Kinniya bridge and Thampalagamam bay (Kinniya Ferry and Thampalagamam bay up the point where the center line of Palampatta aru fall into Thampalagamam bay.
- West* : From the last mentioned point North - West wards along the centre line of Palampotta aru bridge on the Habarana - Trincomalee road. Then North - East Wards in an arbitrary line to a distance of about 9.6 kilometer up to the starting point of the Northern boundary of the area where as 104th kilometer post.

Order

By virtue of the powers vested in me by paragraph (d) of Section 14 of the Urban Councils Ordinance (Chapter 255), I, Dinesh Gunawardena, Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government, do by this order dissolve Trincomalee Urban Council constituted by the order published in *Gazette Extraordinary*, No. 329/8 of 10th August, 1978 with effect from 19th March 2023 in order to constituted Trincomalee Municipal Council.

MUNICIPAL COUNCILS ORDINANCE

ORDER

By virtue of the powers vested in me by Sections 2, 3, 5 and 9 of Municipal Councils Ordinance (Chapter 252), I, Dinesh Gunawardena, Prime Minister and Minister of Public Administration, Home Affairs, Provincial Councils and Local Government, do by this Order -

- (1) Declare the area specified in Part I of the Schedule hereto, to be a Municipality area for the purposes of that Ordinance;
- (2) Define the limits specified in Municipality to be the limits set out in Part II of that Schedule;
- (3) Constitute a Municipal Council for the Municipality declared under paragraph (1) of this Order and assign the following name and designation to such Council:

“Trincomalee Municipal Council”

- (4) Prescribe that the Trincomalee Municipal Council shall consist of number of councilors elected and returned in terms of under-mentioned paragraph i, ii and iii including the Mayor and the Deputy Mayor;
- Fifteen members to be elected under paragraph (a) of Sub section (1) of Section 5 of Municipal Councils Ordinance (Chapter 252) ;
 - Ten members to be elected under paragraph (b) of Sub section (1) of Section 5 of Municipal Councils Ordinance (Chapter 252) ;
 - Such number of members determined by Commissioner of Elections under paragraph (a) of Sub section (4) of Section 65B of the Local Authorities Elections Ordinance (Chapter 262) in terms of paragraph (c) of Sub section (1) of Section 5 of the Municipal Councils Ordinance (Chapter 252).
- (5) The term of office of the members of this Municipal Council shall commence with effect from 20th March 2023.

PART I

The area of land comprising of the following Grama Niladari Divisions:

Manayaveli (244-F), Villundy (244-E), arunagirinagar (244-G), Sonagavadi (244-I), Tillinagar (244-H), Arasadi (244j), Pattanatheru (244-K), Perunteru (244-L), Sivapuri (244-Q), Orr’s Hill (244-P), Thirukadaloor (243-F), Murugapuri (243-G), JinnaNagar (244-O), Abhayapura (244-N), Linganagan (Part) (244-R), Mudcove (244-M), Palaiyoottu (243-D), Poompuhar (243-O), Kovildy (243-P), Singhapura (243-H),

PART II

Administrative limits of the Trincomalee Municipal Council :

North : From the point of 156th kilometer post junction (called 4th mile post) where to Trincomalee - Habarana main Road at 156th kilometers post. North East wards, South - West wards and again North - East wards and North wards along the center line of Trincomalee - Habarana Road to reach the Pillayar Kovil Road at Anpuwalipuram and along the Pillayar Kovil Road (about 0.3 kilometers from Trincomalee - Kandy Road near the 158 kilometers post.) Then North - East wards and North ward, South - West ward, North - East ward and East wards in an arbitrary line to meets Love lane and go through 3rd kilometer post (called 3rd mile post). Then along Ehamparan Road to meets Valarmathi lane junction (about 0.07 kilometers from 3rd kilometer post - called 3rd mile post) then it goes center line of Valarmathi lane to reach sea coast Indian Ocean.

East : From the last mentioned point from South ward, South West wards, North East ward, South West wards, West wards, South ward along the sea coast of Indian Ocean (Black Bay, Thirukoneswar Kovil Edge, Dutch Bay, Sandy Bay, Green Bay beach and Elephant point beach) up to the point where the Elephant Point beach in the Royal Navy.

- South* : From the last mentioned point from East ward, North, East ward, South West wards, North East wards, North West wards, South East wards again North East wards, North West wards, South West wards again North West wards along the Sea Coast (Nicholson Cove, Inner Harbour, Powder Bay, Yard Cove, Mud Cove, North Cove), North ward, North - West ward and South - West ward and arbitrary line up to Railway track (point located near the cement factory) and go through along the railway track to reach railway crossing on Trincomalee - Batticaloa Road.
- West* : From the last mentioned point from North West wards, North East wards along the center of Trincomalee - Batticaloa Road to reach 156 kilometers post and along the center of Trincomalee - Habarana Road.
