## PART I : SECTION (I) — GENERAL

#### SPECIAL COMMODITY LEVY ACT, NO. 48 OF 2007

#### ORDER UNDER SECTION 2 AND SECTION 5

1. BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I Ranil Wikremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodity specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entry in Column II of that Schedule shall be valid for a period of 3 months commencing from September 23, 2022 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

2. BY virtue of the powers vested in me under Section 5 of the Special Commodity Levy Act, No. 48 of 2007, do hereby make an order to waive-off balance amount after collecting Rs. 10 per kg from the applicable Special Commodity Levy of Rs. 40 per Kg. on importation of Salt (Sodium Chloride BP), classified under the HS Code of 2501.00, listed out in the Schedule of the *Gazette Notification* No. 2292/41 dated August 10, 2022 by any pharmaceuticals manufacturing enterprises, registered with the National Medicines Regulatory Authority (NMRA) for the purpose of manufacturing pharmaceuticals, not for commercial purpose, on the recommendation of the Secretary, Ministry in charge of subject of Health. This Order shall be valid for a period of August 11, 2023 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
