The Chairman of Koralaipattu Pradeshiya Sabha in Batticaloa District and Navithanveli Pradeshiya Sabha in Ampara District within the Province of the East has submitted and failed to get adopted the Budget of the year 2023, as the power vested in him under Section 168 and 169 of the Pradeshiya Sabha Act, No. 15 of 1987, thus the said Chairmen of the said Pradeshiya sabha not complied, as provided under Section 17 of the Local Authorities (Special Provisions) Act, No. 21



of 2012, is deemed to have been resigned from the office of the Chairman effective from 30.12.2022 for Koralaipattu and 31.12.2022 for Navithanveli Pradeshiya Sabha that the office of the Chairmen of that Pradeshiya Sabhas become vacant effective from that date.
