#### SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

##### Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this Order impose, in respect of the commodity specified in Column I of the Schedule hereto a Special Commodity Levy, at the rate specified in the corresponding entry in Column II of that Schedule which shall be valid for a period of one year commencing from January 05, 2023 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2284/03 of June 15, 2022 in respect of Sugar (HS Heading of 17.01) and the Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2308/17 of November 30, 2022 in respect of Yogurt (HS Code of 0403.10) and Canned fish (HS Code of 1604.14 - Tunas, skipjack and bonito (*Sarda Spp*)) are hereby rescinded with effect from January 05 2023.
