1. **Acquiring Officer.**– Divisional Secretary, Vavuniya.

2. **Description of the Land.**– The allotments of land more fully described in below names and extents in the Advance Tracing No. VA/VAV/2022/53 dated 28.06.2022 prepared by the Surveyor General, situated in the Village called Karuvalpuliyankulam in the Grama Niladhari Division No. 215 B of Kattarsinnakulam in the Divisional Secretary's Division of Vavuniya in Vavuniya District of Northern Province and bounded as follows:

01. **Lot 'A' – Kurunathadikadu – Extent: 0.3212 Hectare**
