#### STATUTORY DETERMINATION UNDER SECTION 19 OF THE LAND REFORM LAW No. 1 OF 1972

WHEREAS a statutory declaration under Section 18 of the Law has been made by Mr. Ekanayake Rajapaksha Nisiwasala Wataketiye Walawwe Heenbanda of Maliga Walawwa, Madugoda, the Land Reform Commission by virtue of the Powers vested in it under Section 19 of the Law, has made a statutory determination, specifying the portion of agricultural land owned by the statutory lessee which he shall be allowed to retain.
