THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

I. Description of the Land.—Boundaries for the allotment of land bearing names and containing following extents depicted in the Advance Tracing No. MR/MTR/2018/29 and dated 29.07.2018 made by the Surveyor General and situated in the Village of Hungangoda in Matara Four Gravets Minor Division, Divisional Secretary's Division of Matara, Matara District of Southern Province:

II. Description of the Servitude.—Acquiring the servitude right to a part of land which is constructing the access road to the land where the Salt barrier will be constructed under the Matara Water Supply System Phase IV.
