Regulations

The Companies (Secretaries) Regulations, No. 1 of 2023 published in the *Gazette* Extraordinary No. 2323/41 of March 17, 2023 are hereby amended as follows:-

- (1) by renumbering of regulation 6 thereof, as sub-regulation (1) thereof;
- (2) by the addition immediately after the renumbered sub-regulation (1) thereof, of the following sub-regulation which shall be numbered as sub-regulation (2) of that regulation: -
 - "(2) Every Certificate of Practice issued under sub-regulation (1) shall be made in the Form set out in the official website of the Department of the Registrar of Companies."; and
- (3) by the insertion of sub-regulation (1A) immediately after sub-regulation (1) of regulation 9, of the following: -
 - "(1A) Every application for renewal of the Certificate of Practice individual or Certificate of Practice body corporate or firm under sub-regulation (1) shall be made in the Form set out in the official website of the Department of the Registrar of Companies."
- (4) in paragraph (a) of regulation 11 thereof, by the substitution for the words and figures "in paragraph (d) of sub-regulation (1) of regulation 3;" of the words and figures "in paragraph (e) of sub-regulation (1) of regulation 3;".
