- Non-payment of service charges from March August 2022
- Deduction of 10% from the service charges monthly from March 2020 to March 2023 for damages caused and non payment of the balance amount during those 03 years
- deduction of Rs. 300/= monthly for welfare from 65 employees for 02 years
- employee appraisal not done for 05 years and non-payment of salary increments
- salary not been increased for 05 years
- not providing a monthly salary slip

Hotel Concord Grand

- Non-payment of service charges from March August 2022
- Deduction of 10% from the service charges monthly from March 2020 to March 2023 for damages caused and non payment of the balance amount during those 03 years
