### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Depicted in the Advance Tracing No. KU/EHT/2016/825 and 28.12.2017 prepared by the Surveyor General, situated in the village of Bogassewa and Hammillewa in the Grama Niladhari Division No. 112 Wikadenigama in the Divisional Secretary's Division of Ehetuwewa in Kurunegala District in Northern Western Province and bounded as follows:

##### 01. Lot No. 01 – Extent: 5.4019 Hectares

North, East and South: Government Forest Reserve; West: 2nd plot of land and Government Forest Reserve.
