FOREST CONSERVATION ORDINANCE

THE Order under Section 4(2) that has to be read with the Section 64.(1) of the Forest Conservation Ordinance (Chapter 451) No. 13 of 1966 as amended by Acts No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009.

The Order

By virtue of powers vested in me under Section 4(2) of the Forest Conservation Ordinance (Chapter 451), I, Pavithra Wanniarachchi, Attorney-at-Law, the Minister of Wildlife and Forest Resources Conservation do by this Order release the block of forest land of the extent 2.0235 ha. of the Gurugodakanda Reserved Forest bounded by the limits set forth in the Schedule given below and was declared as a Reserved Forest by *Gazette Extraordinary* Notification No. 1787/30 dated 06th December 2012 from the Reserved status from 01st day of November, 2023.
