I hereby give notice under Sub-section (1) of Section 7 of Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No.28 of 1964 that the Government has acquired the allotment of lands required for the construction of a maintenance and monitoring office to protect and maintain the water ponds, canals and water reserves constructed under Weras Ganga Storm Water Drainage and Environment Improvement Project.
