THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Lands described below are needed for a Public purpose and will be acquired under the provisions of the Act.

The Land of below mentioned Name and Extent, depicted in Advance Tracing No. R/AYG/2021/26 and dated 28.06.2022 prepared by the Survey General, Situated in the villages of Paragala (F.V.P. 224) and Udugala (F.V.P. 239) in the Minor Division of Kukulu Korale Pallepattuwa in the Divisional Secretary's Division of Ayagama in Ratnapura District in Sabaragamuwa Province and bounded as follows:
