PRADESHIYA SABHA - NATTANDIYA

IT is hereby notified for the public information that it has been adopted under the resolution No. 2454 moved at the General Conference held on 04.12.2023 at Pradeshiya Sabha Nattandiya that all the roads and thoroughfares for which legal action had not been filed in a proper Judicial Court before the date specified or roads and throughfares confirmed as the roads and thoroughfares that should be owned by Pradeshiya Sabha Nattandiya as per the Decree of a Judicial Court in which a case has been filed before the said date and not mentioned in the following Schedule from among the roads and thoroughfares given in the list of the schedule of the notification published in the *Extraordinary Gazette* No. 2341/55 and dated 21.07.2023 shall be confirmed as roads and thoroughfares owned by the Pradeshiya Sabha Nattandiya in terms of orders made by the series of "orders on publications of notifications specifying preparation of plans and lists for roads and thoroughfares maintained by the Pradeshiya Sabha within the North Western Province" published by *Extraordinary Gazette* No. 2238/35 and dated 30th July 2021 by the Hon. Governor in the North Western Province and in terms of the Order by Section 24(1) of Pradeshiya Sabha Act, No. 15 of 1987.

It is further notified that, a list of said roads and thoroughfares has been included in the Schedule here to and all the roads and thoroughfares mentioned in that schedule shall be considered as roads and thoroughfares owned by the Pradeshiya Sabha Nattandiya under Sub Section (5) of Section 24 of Pradeshiya Sabha Act.
