#### PORTS AND AIRPORTS DEVELOPMENT LEVY ACT, No. 18 OF 2011

##### Order under Section 3

BY virtue of the powers vested in me by Sub-section (3) of Section 3 of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies do hereby, amend the Order published in the *Extraordinary Gazette Notification* No. 2312/67 dated December 31, 2022 as last amended by the *Extraordinary Gazette Notification* No. 2350/45 dated September 21, 2023 by addition to the Schedule IV thereto of the Articles specified in Column III corresponding to the HS Headings and HS Codes specified in the Column I and II as exempted in Column IV of the Schedule hereto.

This Order shall come in to effect from January 01, 2024.
