I hereby give notice, under Sub section (1) of section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act. No. 28 of 1964, that the Government has acquired the allotment of marshy land located between Piliyandala-Moratuwa bus route and Temple Road for canal development, creating a water tank, townscape development and other developments under Weras Ganga Storm Water Drainage and Environment Improvement Project.
