Further the person should appear for an inquiry under section 09 of the Act, commence from 24.04.2023 onwards. The date of inquiry and the relevant documents to be submitted at the inquiry such as deeds may duly informed by me.

If an agent present at the inquiry, original claimant of the land must be duly authorized in writing. Without such a letter statement or evidence may not be recorded from such an agent.
