CIVIL AVIATION AUTHORITY OF SRI LANKA ACT, No. 34 OF 2002

Order under Section 9

BY virtue of the powers vested in me under Section 9 of the Civil Aviation Authority of Sri Lanka Act, No. 34 of 2002, I, Nimal Siripala De Silva, Minister of Port, Shipping and Aviation, do by this order, amend th Schedule to the Order published in the *Gazette Extraordinary* No. 2050/38 dated 21st December 2017, which specifies under the "Aeronautical Facilities and land appertaining thereto" as follows.
