# Notice under Section 7

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following allotments of lands which are required for establishing a Breeding Center for the Elephants in the Pinnawala Elephant Orphanage.
