**STATUTORY DETERMINATION UNDER SECTION 19 OF THE LAND REFORM  
LAW No. 1 OF 1972**

WHEREAS a statutory declaration under section 18 of the Law has been made by Mr. Kongahakankanamge Don Piyumarathne Perera of “Somasiri”, Galpatha, Pelpola, the Land Reform Commission by virtue of the powers vested in it under Section 19 of the Law, has made a statutory determination for his estate as he has passed away as of now, specifying the portion of agricultural land owned by the statutory lessee which he shall be allowed to retain.
