2. **Description of the land** - For allotments of land more fully depicted in following names and extents in the Advance Tracing No. R/AYG/2021/47 dated 09.08.2021, prepared by the Superintendent of Surveyor, situated in the village called Dumbara (F.V.P. 52) in Kukul Korale, Palle Pattu Minor Division in the Divisional Secretary's Division of Ayagama in Rathnapura District of Sabaragamuwa Province and bounded as follows.
