Upon the Petition, &C., the Commercial High Court of Colombo on the 21st day of March 2023 doth ordered that the winding up of the said The Finance Company PLC *alias* The Finance Company Limited be carried out subject to the Supervision of the Court; and the Court ordered that Mr. Gerard Jeevananthan David, C/o, S J M S Associates, 3rd Floor, No. 11, Castle Lane, Colombo – 04 be appointed as Liquidator of the said Company. And the Court ordered that the said Mr. Gerard Jeevananthan David do on the 26th day of April 2023 next, and thenceforth every three months file with the Secretary of the Court a report in writing as to the position of, and the progress made with, the winding up of the said Company, and with the realization of the assets thereof, and as to any other matters connected with the winding up as the Court may from time to time direct, and the Court ordered that no bills of costs, charges, or expenses or special remuneration of any proctor employed by the Liquidator of the said Company or any remuneration, charges, or expenses of such Liquidator, or of any manager, accountant, auctioneer, broker, or other person, be paid out of the assets of the said Company unless such costs, charges, or expenses, remuneration shall have been assessed or allowed by the Secretary of the Court. And the Court ordered that all such costs, charges, expenses and remuneration, be assessed and ascertained accordingly. And the Court ordered that the Petitioner for his cost, and the creditors, contributories, and Liquidator of the said Company, and all other persons interested, are to be at liberty to apply generally as there may be occasion.
